

## COMPLETE RULES (“Official Rules”) of the “Cartoon Network Football Prize Competition 2016” Promotion

### 1. NO PURCHASE NECESSARY TO ENTER OR WIN

Turner Broadcasting System Europe Limited, a company, with its registered office at Turner House, 16 Great Marlborough Street, London W1F 7HS, United Kingdom, registered as company number 01927955, which produces the television channels known as Cartoon Network, Cartoonito and Boomerang in the UK (hereinafter called “Promoter”), is holding a free prize competition entitled “Cartoon Network Football Prize Competition 2016” (the “Promotion”) from 00:00:01 BST on 1 June 2016 until 23:59:59 BST on 10 July 2016 (the “Entry Period”) on the website with the URL [www.cartoonnetwork.co.uk/goal](http://www.cartoonnetwork.co.uk/goal) (the “Site”).

### 2. HOW CAN YOU PARTICIPATE?

The Promotion is open to all residents of the United Kingdom of Great Britain and Northern Ireland aged between 4 and 15 (inclusive) who have internet access throughout the Entry Period except that employees of Promoter, and its parent, subsidiary, affiliated or associated companies, its and their agents and immediate families and anyone else professionally connected with the Promotion (the “Released Parties”) are not eligible to participate.

All entrants must have parental/guardian consent to enter and their parent or guardian must agree to these Official Rules for themselves and on behalf of the minor. By entering this Promotion each entrant confirms that he/she has obtained such consent and confirms that he or she has obtained the required parental/guardian consent.

Entry is limited to one (1) entry per person. Any attempt by any entrant to exceed the entry limit by using multiple/different e-mail addresses, identities, or any other methods will void all that entrant's entries and that entrant will be disqualified from the Promotion.

### 3. HOW TO ENTER

Entries should be made in accordance with the instructions given for the Promotion via the Site.

By entering the Promotion, entrants confirm that all information given is complete, accurate and not misleading. Promoter reserves the right, in its sole discretion, to disqualify any entry at any time in the event it is determined that the entrant has not complied with these Official Rules or has acted in an unsportsmanlike or disruptive manner. The Released Parties are not responsible for misdirected, incomplete, lost, late, illegible, undeliverable entries, technical, hardware, or software failures of any kind, lost or unavailable network connections, failed, incomplete, garbled or delayed computer transmissions or other errors or problems which may limit or affect an entrant's ability to participate in the Promotion. The Released Parties are not responsible for other errors or difficulties of any kind, whether human, mechanical, electronic, computer, network, typographical, printing or otherwise, relating to or in connection with the Promotion, including without limitation, errors or difficulties which may occur in connection with the administration of the Promotion, the processing of entries, the announcement of the prize or in any Promotion-related materials. The Released Parties do not guarantee that the Site and/or game will not contain IT faults, or that faults identified will be remedied; nor can they guarantee that the Site and/or sites to which the Site links do not contain viruses or other components which may cause damage to entrants' computer equipment and/or data. In the event of sabotage, acts of God, terrorism or threats thereof, computer virus or other events or causes beyond the Promoter's control, which corrupt the integrity, administration, security or proper operation of the Promotion, Promoter reserves the right, in its sole discretion, to modify, cancel or suspend the Promotion (or a portion thereof). In the event of cancellation, Promoter reserves the right to choose from all eligible, non-suspect entries received prior to the event requiring such cancellation. False or deceptive entries or acts will render the entrant ineligible.

### 4. WINNERS

There will be thirty (30) winners (each a “Winner” and together the “Winners”).

The Winners will be selected at random by the Promoter from all correct online entries received. The decisions of the Promoter will be final and binding in all matters.

All entrants selected in the Promotion as prize winners are subject to verification of eligibility and compliance with the terms of these Official Rules. An entrant is not a Winner unless and until the entrant's eligibility has been verified and the entrant has fully complied with these Official Rules.

Promoter must have received signed Releases (as described in section 5 below) before any entrant may be considered a Winner of the Training Centre Experience or Stadium Experience (as described in section 5 below).

## 5. PRIZES

Each Winner will be assigned one of the following prizes at random:

<b><u>PRIZE</u></b>	<b><u>NUMBER OF WINNERS</u></b>
<b><u>Training Centre Experience</u></b> The Winner plus three (3) friends (also aged between 4 and 15 inclusive) (supervised by one (1) responsible parent or legal guardian aged 18 or over) shall attend the training complex of Tottenham Hotspur Football Club (" <b>THFC</b> ") at Hotspur Way, Enfield EN2 9AP and take part in activities to include a training session with Spurs Foundation coaches, a Q&A session with two (2) THFC squad members, watching the THFC first team train and receiving THFC sportswear. There shall be one (1) Winner from each of the following age groups: 4-6 years, 7-9 years, 10-12 years and 13-15 years. The date of the Training Centre Experience shall be notified to the applicable Winners in due course but shall take place no later than 31 May 2017.	4
<b><u>Stadium Experience</u></b> The Winner plus one (1) responsible adult aged 18 or over shall each receive one (1) ticket to a THFC home match of THFC's choosing in the 2016/17 season.	4
<b><u>Merchandise</u></b> THFC replica football shirt signed by a selection of THFC players	2
<b><u>Merchandise</u></b> THFC football signed by a selection of THFC players	2
<b><u>Merchandise</u></b> THFC goody bag to include items such as THFC collectible tin, boot bag, flag, poster and pin badge.	20

The four (4) Winners of the Training Centre Experience and each such Winner's three (3) guests must together be accompanied by one (1) responsible adult aged 18 or over. Such accompanying adult will be specified in the Release and shall be responsible for the Winner and his or her guests at the Training Centre Experience.

The parent/guardian acknowledges that participation in the Training Centre Experience may involve an element of physical exertion and they have consented to their child participating in the Training Centre Experience and confirms that their child is physically capable of doing so and that the accompanying responsible adult is responsible for their safety while doing so.

The four (4) Winners of the Stadium Experience must each be accompanied by one (1) responsible adult aged 18 or over. Such accompanying adult will be specified in the Release and shall be responsible for the Winner at the Stadium Experience.

In respect of (a) Winners of the Training Centre Experience, their three (3) guests and one (1) responsible adult; and (b) Winners of the Stadium Experience and one (1) accompanying responsible adult, Promoter shall contribute up to a maximum of £140 per person towards the reasonable standard class travel expenses from a UK address to the training centre or stadium (as applicable). No accommodation shall be provided as part of the Training Centre Experience or Stadium Experience.

Promoter shall not be responsible for any travel-related delays or cancellations. Prizes are awarded with no warranty or guarantee, either express or implied by Promoter. The Winners and their guests shall be responsible for the reporting and payment of all applicable taxes (if any) as well as any other costs and expenses associated with acceptance and use of a prize not specified herein as being awarded.

All prize details not specified herein are at the sole discretion of the Promoter. Promoter reserves the right to substitute any prize (or portion thereof) with one of comparable or greater value, in its sole discretion. Prizes are subject to the terms and conditions of the applicable manufacturer, supplier and/or operator. Prizes must be accepted "as is" or declined. Prizes may not be transferred or exchanged for another article or cash value. It is agreed if the prize is awarded to a minor the prize will be delivered to his or her parent or guardian, or to the winner with the written consent of his or her parent or guardian.

Notice of the win will be sent to Winners within thirty (30) days of the end of the Promotion via the email address provided at the point of entry. In respect of Winners of the Training Centre Experience and the Stadium Experience, Promoter shall also send a release form for such Winner and each of his or her guests (a) dealing with use of any publicity including the Winner and his/her guests; and (b) nominating the responsible adult(s) who will accompany the Winner and his or her guests to the training centre or stadium (as applicable) (the "**Releases**").

Entrants need to ensure that the email address is accurate and functioning.

Winners must confirm his or her willingness to receive the prize within a period of two (2) weeks from the date of such contact, giving his or her name and postal address for delivery of the prize. In respect of Winners of the Training Centre Experience and the Stadium Experience, such Winners (or the parent/guardian thereof) will need to return the Releases signed by the parent/guardian of such Winner and of each of his or her guests.

Winners will forfeit their prize if it is not accepted in that period and the Promoter will be entitled to pick another winner. The Promoter may cancel the winning of a prize in its sole discretion and without prior notice if it does not receive confirmation from the winner of willingness to receive the prize or if the shipping of the prize to the address stated by the winner is unsuccessful, and the organizer fails to obtain the necessary information to deliver the prize successfully following reasonable efforts. In this case the Promoter will consider itself obliged to cancel the prize, without the person concerned becoming entitled to any compensation as a result and with Promoter reserving the right to select an alternative winner. Where applicable Promoter shall dispatch the relevant prize within two (2) weeks of receiving relevant details.

## **6. ENTRANT MATERIALS**

As part of the Promotion, Promoter will require entrants to submit to Promoter:

- a. his or her first name and age; and
- b. email address of the entrant's parent or legal guardian which will be used only to contact the First Prize Winner and the Runners Up ((a) and (b) together being the "**Entrant Materials**").

Promoter shall use the Entrant Materials together with any other personal data submitted to it under this Promotion, for the purposes of properly administering the Promotion. The Released Parties expressly disclaim any responsibility for any and all claims, actions, demands and/or liability for injury, damage or loss whatsoever relating to or arising in connection with participation in this Promotion (regardless of the cause of such injury, damage or loss), Promoter's use of any footage and/or the delivery and/or subsequent use or misuse of any of the prize awarded (including without

limitation, any travel and activity related thereto). For the avoidance of doubt the Released Parties do not exclude their liability for death or personal injury caused by their own negligence.
